Negative Observations: It tells us how many times(%) the scheme has given negative observations in the selected period. (Lower the better)

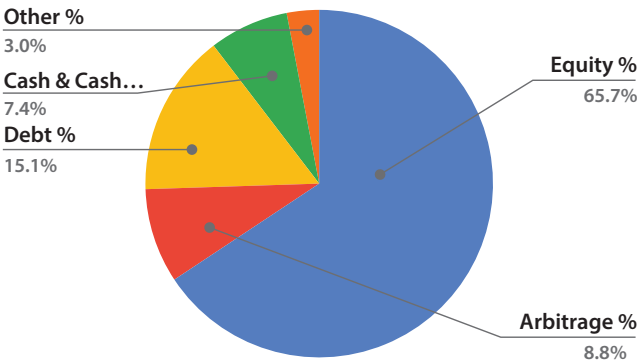
